3. Description of Problem, Suggested Intervention and List of Items

As the winter season of 2026 rapidly approaches, Ukraine faces an acute humanitarian crisis resulting from the targeted destruction of its energy infrastructure. Russian missile and drone attacks continue to devastate heating plants, transformer stations, and power grids across the country. More than 100 communities are currently experiencing daily shortages of heating and other vital resources, with outages lasting up to 12 hours per day. Without immediate support, households near the frontline regions, particularly in eastern and northern Ukraine, will be left in freezing conditions, forcing families to flee their homes or endure life threatening temperatures. To mitigate this crisis, it is essential to provide reliable, independent sources of heating.

We respectfully request your urgent support to deliver gas convection heaters, powered by portable PB bottles, for distribution across vulnerable cities in Dnipropetrovsk region in Ukraine.

Advantages of the proposed solution

- **Operational independence:** These heaters function without connection to Ukraine's damaged central grids.
- **Safety and efficiency:** Units include sealed combustion chambers with external flue exhaust, automatic gas shut off in case of malfunction, and thermostatic control (13°C–38°C).
- **Rapid humanitarian deployment:** Heaters can be installed both in permanent apartments and in modular/emergency accommodation.
- **Energy resilience:** Independent room based operation allows targeted heating, conserving fuel and ensuring optimal use of resources.

Every day of delay decreases the capacity of Ukrainian families to prepare adequately for extreme winter conditions. If procurement and distribution are not initiated in September, delivery and installation may fall behind the onset of freezing weather. Timely supply of heaters from humanitarian budgets will directly save lives, alleviate pressure on displaced populations, and demonstrate tangible solidarity with Ukraine.

Engage suppliers able to provide heaters in large volumes. Coordinate delivery with Ukraine's regional authorities and international humanitarian actors for rapid distribution. Providing these gas heaters is a practical and lifesaving measure. With winter weeks away, this support is not only humanitarian but necessary to protect civilians from preventable suffering.

Funding from Czech government will empower us to quickly purchase, deliver, and install these heaters in homes and shelters that would otherwise remain cold and unsafe during the coming winter months. Lives can be saved, and health protected, by this concrete intervention.

- connection to mains is not required
- piezoelectric ignition with a pilot light

- both natural gas (G20) and propane-butane (G30) use possible (consumption – Natural gas (m³/h) 0,37, Consumption – propane-butane (kg/h) 0,24)
- efficiency 85-90%
- construction of exhaust by pipe-in-pipe system (60 cm or 82 cm diameter exhaust tubes)

Type 2:

- 2.0 kW heat output
- heats spaces up to 40 m³
- target room temperature is maintained automatically
- mechanical temperature control for a heat range of 13°C to 38°C
- connection to mains is not required
- piezoelectric ignition with a pilot light
- safe operation
- gas-tight combustion chamber
- wall mounting system
- both natural gas (G20) and propane-butane (G30) use possible (consumption – Natural gas (m³/h) 0,37, Consumption – propane-butane (kg/h) 0,24)
- efficiency 85-90%
- construction of exhaust by pipe-in-pipe system (60 cm or 82 cm diameter exhaust tubes)



Data protection information

The following information is provided on the basis of Article 13 of the GDPR¹:
